### EMAIL AND FAXED ENTRIES ACCEPTED. NOTE:

Faxed or other electronic entries are not guaranteed until payment is received. Fax/Email entries MUST be PAID within 10 DAYS of entry or a \$5 per entry fee will be assessed at check-in. If the show fills, entries not paid will be placed on a waiting list behind those entries already paid in full.

**\*CFA Cat Agility Entry Information:** To be held both days! **\$10 entry fee which includes a trial run.** Just note on your entry that you are also entering the cat agility contest. Cats not entered in the show are eligible to enter and **there is a \$25 fee for a single cage in addition to the \$10 entry fee.** Please contact the entry clerk for an entry form if you are only entering agility.

**\*Junior Showmanship:** A Junior Showmanship Program will be conducted on Sunday. Entry fee is \$5.00. CFA Junior Showmanship information can be found at: <http://www.cfainc.org/shows/jr-showmanship.html>

**\*Show Hours: Check-in will be from 8:00am - 9:30am on Sat.** Advertised show hours are **Saturday from 10:00 am to 4:30 pm** and **Sunday from 9:00 am to 4:00 pm.**

**\*Show Hall:** Directions to the Fairgrounds will be sent with your show confirmation.

**\*Transportation:** Exhibitors are responsible for their own transportation.

**\*Scoring:** All Championship, Premiership, and registered Kitten entries will be scored for CFA National and Regional awards.

**\*Vetting:** The show is non-vetted. All entries should be inoculated by a licensed veterinarian against feline panleukopenia, feline rhinotracheitis, calici virus, rabies, and tested negative for FeLV before entry. All claws of entries must be clipped prior to benching.

**\*Miscellaneous:** Show management will take reasonable care of cats and carriers, but will not be responsible for losses and damages. The show hall is a NON-SMOKING facility and is heated & air-conditioned.

**\*General:** CFA rules will be enforced. A copy of the show rules may be obtained for \$5.00 from CFA, PO Box 1005, Manasquan, NJ 08736. Registration numbers for cats entered in championship and premiership classes must be printed in the catalog. It is the exhibitor's responsibility to check entry confirmation and notify the entry clerk of errors.

**\*Food and Supplies:** Food service for exhibitors will be available. Litter will be provided. Bring your own litter pans and cat food.
